OUR SELF-EVALUATION REPORT AND IMPROVEMENT PLAN May 2018

In the last year, we have looked at teaching and learning in our school to find out what we are doing well. This is what we discovered:

Group	Literacy rating	numeracy rating	response rate
Parents	8	8	79%
Students	8	8	100%
Teachers	8	9	100%

1=poor 10=excellent

85% of students agreed that explaining keywords helps them understand a topic.

75% of students have been calculating and recording % from test results in Maths and Science.

94% of students stated that there is evidence of numeracy in classrooms (posters. Height charts etc)

69% of students stated that it is helpful when they are told the learning intentions at the start of the lesson (27% of students were unsure, only 4% stated they were not helpful) 73% of students stated that summarising at the end of class would enable them to clarify what they have learned.

On a scale of 1-10 (1= not happy, 10= extremely happy) the students rated their happiness in Coláiste Abbáin as an 8.

Students rated the following the top 6 teaching strategies, resources used by teachers to help them understand a topic

69% Keywords

48% Paired, group work

48% Discussions

52% Youtube

38% Quizzes

35% Homework

69% of students stated that it is helpful when they are told the learning intentions at the start of the lesson.

73% of students stated that summarising at the end of class would enable them to clarify what they have learned.

83% of teachers have used 'think pair share, 48% Visual Verbal Square, 74% placemat this academic year

82% of parents like to get JCSP postcards, text messages and other forms of positive recognition from school.

This is what we did to find out what we were doing well, and what we could do better:

- Random number of students surveyed via google docs across the whole school on 23rd April 2018. (48 students 8 per year group, 100% response rate)
- Parents' google docs survey hard copy data entered by Deputy Principal to ensure higher response rate.
- All teachers surveyed google docs survey to be completed by 27TH April 18
- Relevant personnel reflecting over DEIS and SSE targets on noticeboard.
